



Non-Therapy Ancillary Services—Conditions/Extensive Services

- ▶ Non-Therapy Ancillary Services (NTA) classification is determined by the presence of certain conditions or the provision of extensive services that are associated with additional costs for medical care. A weighted co-morbidity scoring process is used to create the NTA component of the total reimbursement for care and services for Medicare A recipients.

Diagnoses and conditions included in this classification should be entered into the resident's electronic health record, as appropriate. Care and services related to these diagnoses and/or conditions are documented in the resident's electronic health record, as indicated.

The following conditions and extensive services categories are used in the Non-Therapy Ancillary Services scoring component:

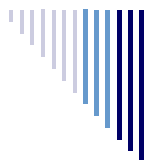

The Non-Therapy Ancillary Services (NTA) component is a total score of all listed conditions and/or extensive services that apply to the resident. The score determines NTA payment groups and indices. These groups and indices, combined with other components of the payment system, provide a total reimbursement process that improves payment accuracy while focusing on a more resident-centered care model that is unique, individualized, and takes into account the characteristics and goals of the resident.
